Cancellation Policy

Using Personal Information

- Collect payments from you

In addition to the disclosures reasonably necessary for the purposes identified elsewhere above, Smith House may disclose your personal information to the extent that it is required to do so by law, in connection with any legal proceedings or prospective legal proceedings, and to establish, exercise or defend its legal rights.
